A model has been developed but there have no words about benefits of the model for a country.</li> <li>&gt;In introduction, it should be introduced the present research works with other topics related to this research. So introduction must be revised.</li> <li>&gt;In line 97-98: It is better to use 'National Mobile Market Structure in Turkish' as a heading.</li> <li>&gt;In line 252-272: It is better to write few words in favour of putting Ref. [4], [14, 3], [21] so that any reader can easily understand about the justification of these references.</li> <li>&gt;It is better to add some recent references in the paper. Maximum References are old.</li> </ul>
