

Compulsory REVISION comments	 Model wrongly specified. The work is not on economic growth but impact of government expenditure on growth in Agricultural output. so your model can be specified in this form: AGRICOUTPUT = f(REXPA, DDEBT, NOR, INFL, INTR) 2. Author needs to show the result for the test of optimum lag length before showing the cointegration result. 3. There is need to re-examined the result of causality test for correct interpretation. For instance, the result in table (3) shows that there is no causality between INTR and AOUP 4. Authors not cited in the work should be removed from the list of references. E.g. Abayomi (2002), Anyanwu, (2004) etc. 5. OLS result not provided in the work, this is highly necessary for readers to see. 	
Minor REVISION comments	 Section 3.0: the theoretical framework reviewed for the study seems not to capture the objective of the paper, which is impact of government expenditure on sectoral productivity. A review of Keynesian macroeconomic thought could have been of help.
