The aim is clear and the experimental design is sound; besides, experiments testing the health effects of plant extracts in live animals are always necessary. Hence, this study was well-performed, well-documented and the manuscript is well prepared and arranged following the journal authors instructions. The article is full of grammatical errors, try to use quality of simple English layout. The introduction provides a clear background, define problem and propose solution. But the number 3 sentence in methodology should be the second sentence and number 2 sentence should be the third sentence. In the result sections, the tables should be in the following order; tab. 1=body weight, tab. 2=weight gain, tab.3=liver weight. Then, followed it with the other tables as stated initially. Also, do not use abbreviation on the title or sub title, e.g, Table 1: <del>ALT activities in control and treated rats</del>: Alanine aminotransferase activities in treated rats. Correct that of tab. 2, 3, 4 and 5, and do not add in control in the heading. Results are not described in a concise manner, discussion is presented clearly with detailed interpretation of data and conclusion briefly stated the major findings of the work. The reviewer recommended the manuscript for general revision, especially thorough English organization before</p>
